FAMILY VIOLENCE INTERVENTION – IDENTIFICATION AND INTERVENTION

POLICY STATEMENT

Te Whatu Ora – Health New Zealand Te Whatu Ora Hauora a Toi Bay of Plenty recognises that they owe a duty of care to protect and promote the wellbeing of any unborn, child, young person or adult with suspected, witnessed, reported or disclosed violence, abuse or neglect.

Te Whatu Ora Hauora a Toi Bay of Plenty is committed to ensuring staff are competent in the identification and intervention of actual or suspected abuse or neglect through organisational infrastructure including management support, policy and protocol documents, workforce development, quality improvement activities and access to consultation.

The rights, welfare and safety of the child / Tamariki, young person / Rangatahi are our first and paramount consideration.

PURPOSE

To set out the expected performance and responsibilities of the Te Whatu Ora staff / contractors to identify, manage / refer suspected, witnessed, reported or disclosed violence, abuse or neglect of any type (physical, emotional / psychological, sexual abuse) that complies with Ministry of Health (MOH) guidelines and other relevant legislation.
