INCIDENT MANAGEMENT

POLICY STATEMENT

Bay of Plenty District Health Board (BOPDHB) will comply with the National Adverse Events Reporting Policy 2017, New Zealand Health and Disability Services and with the legislative requirements as stipulated in the Health and Safety at Work Act 2015. All incidents, healthcare and other, that occur within BOPDHB facilities and / or services or affecting BOPDHB employees at work, will be reported and investigated using robust processes to ensure lessons are learnt and recommendations are actioned.

PURPOSE

The purpose of the policy is to:

- 1. Provide governance that clearly outlines all BOPDHB responsibilities in incident management
- 2. Ensure consistency in the approach to incident management across BOPDHB health services
- 3. Provide a system that facilitates the identification, reporting, reviewing, monitoring and evaluation of all incidents in a timely and effective manner
- 4. Ensure those involved in, or affected by, incidents receive appropriate assistance and support
- 5. Ensure organisational learning from incidents, including near-miss events and system failures, to mitigate future risk
- 6. Increase awareness of reporting requirements and related legislation

PRINCIPLES

This policy is underpinned by the following principles:

- 1. *Obligation to act* key stakeholders acknowledge and understand their roles and responsibilities in the incident management.
- 2. *Just culture* incidents are reported and acknowledged without fear of blame or retribution and individuals are treated fairly in an open and honest manner.
- 3. *Prioritisation of action* investigation of incidents is prioritised by the health service in order to facilitate timely and effective reviews of high impact incidents.
- 4. *Emphasis on learning* a focus on learning from incidents as a means to improve the quality and safety of care across BOPDHB publicly funded health services.
